

REGULATION OF LA BOURSE DE MER 2012

1 About La Bourse

- 1.1 Organizer : AFAHA (Association Française des Amateurs d'Horlogerie Ancienne)
- 1.2 Purpose : To allow exchanges between people who have a keen interest in horology
- 1.3 Dates / Times : March 24 from 2.00 pm to 7.00 pm .
 March 25 from 10.00 am. To 5.00 pm.
- 1.4 Location : **MER** (close to Blois, Loir et Cher, France) in La Halle (covered market).

2 Organizer's responsibilities

- 2.0 Expert's services : At disposal free of charges for exhibitors and visitors . The organizers will pay the expert's fees.
- 2.1 Locale : A well appointed main floor exhibition hall (Lights , plugs , washroom , water distribution)
- 2.2 Exhibition tables: Cloth covered tables - width:0.85m length: from **2m to 4 meters maximum** per exhibitor .
- 2.3 Insurance: The exhibitors must give take all precautions to prevent the risks of shoplifting, degradations...
- 2.4 Security : The bulding is up- to-rftdate .A security gard will be on duty from saturday 7.00 pm to sunday 9.00 am .
- 2.5 Advertising : The particulars of the event will be advertised in national and local papers, in specialized press and media . Orientation signs will be placed at the city's main entrance routes.
- 2.6 AFAHA secretaries will be responsible for taking registrations and sending confirmation receipts.
- 2.7 Welcome: upon arrival, before proceeding to your exhibition table , you must collect your indentify's badge, present valid ID (citizenship card . driver's licence , passport...) and sign the Exhibitor's registry
- 2.8 Setting up and removal of exhibition material:
Setting up : saturday 7.00am to noon
Removal : sunday 5.00pm to 8.00pm
The exhibition hall will be closed on saturday between noon and the opening event
On sunday the removal will be not permitted before 5.00 pm as a respect for the visitors and the others exhibitors. Non respect of this will automatically prevent the registration of the exhibitor for the next event " A La Bourse De Mer".

Be careful !!!

No registration (exhibitor or co-exhibitor) will be possible on the spot. We remind you that the exhibitor can have only one co-exhibitor .

For security reasons only people wearing a identify's badge will have access to the Exhibition hall outside hours permitted to the public. (see § 3.1)

3 Condition of admission :

.1 Exhibitors must be a member, in good standing , of an horology association , French or other contries , (proof of up-to-date membership will be required at time of registration)

Or be invited by the organizer (School of horlogery , Museum ,...)

Your registration can not be transferred to other person except immediate family members (a spouse or child).

If you have to be accompanied by another person (one maximum) He/She must folow the same registration procedures (see § 4.6) as yourself and pay the registrtion of 30 €

3.2 Visitors ' admission : Saturday from 2.00pm to 7.00p .

Sunday from 10.00am to 5.00pm .

4 Exhibitors'responsabilities :

4.1 Displayed items : Only antique mechanical or electrical time pieces are allowed (watches , clocks , tools , books ,) .

Shan be categorically excluded all new/recent time-pieces and items that are unrelated to horology (jewellery , numismatic , purchase of precious metal etc ...) And the publicity of this activities No exeption shall be made .

4.2 Setting up : No items are to be left in passageway . Please ensure you have adequate table space.

4.3 Animal : No permitted in theExhibition hall .

4.4 No smoking in the Exhibition hall .

4.5 Billstiking : All of the prices must be properly post up .

4.6 By signing a registration form , the participant commist himself for the duration of the Exhibition (2 days) .

5 Cost :

5.1 Exhibitors : 3 standard modèle of stand ares availables : 2 ml (80 €), 3 ml (120 €), and 4 ml maxi (160 €)

5.2 Co-exhibitor : 50€

5.3Visitors : AFAHA's Member: 2 € ; Other : 3 € ; Student (student's card requiers) and children : free .

5.4 Method of payment for exhitors : Please refer to the registration form . The cheque for the full amont , made payable to l' AFAHA , must be enclosed with your registration form . Cheques will deposited 3 weeks before the event .

6 Cancellation :

6.1 By the exhibitor : If your cancellation is recevied before March 10 , we will return your cheque . Cancellation are not accepted after March 10 , unless if another exhibitor takes yor place . In this case you will be fully reimbursed .

6.2 By the organizer : If , for raison out of our contol , La Bourse should have to be cancelled , we will return your cheque promptly .

7 Method of registration :

7.1 The organizer will officially confirm a registration ONLY if the exhibitor :

- a. filled out a registration form and will agree to the regulation by writing "approved " in front of his/her name
- b. Enclosed a cheque for the full amount due
- c. Enclosed a stamped self-addressed envelope (in order to mail a confirmation receipt) .

7.2 Registration form must be return by **January 31, 2012** .

After the above date , you will be put on waiting list until a spot becomes available .

All non-deposited cheques will be returned , at the latest , during the week after the event .
